




A START SANTÉ LOAN TO

HELP BUSINESSES START UP

Starting a business in Health or So-cial Care is not easy, in particular for structures that have been granted a new subsidy or recognition by AVIQ (Walloon Agency for a Quality Life) or NIHDI. Institutions may experience cash flow difficulties in their start-up phase, due to the fact that several months may elapse between the granting of the subsidy or agree-ments from insurers and the funds actually being paid out.

This is where WALLONIE SANTÉ comes in, with the new START Santé loan. It consists of a short-term li-quidity loan that can be activated for structures (two years old or less) which have been granted subsidies that have not yet been released (or have been only partially released), as well as for AVIQ or NIHDI-recognised structures experiencing a time lag between invoicing and re-ceipt of payment from insurers when starting up.
